Information about the Rules Workshops:

Due to increased adoption of the ICU and ECU safety rules on the national level as well as for open international and even commercial competitions, the understanding and consistent interpretation of those rules has become one of the most important requirements for national rules bodies, safety judges and of course coaches. ICU is supporting these trainings by providing top experts, who are directly involved in the creation and interpretation of these rules to deliver the Safety Rules Training.

Information about the Judges Course:

This course is intended for judges with intermediate experience, looking to transition from national level judging into international judging. The course is the basis for achieving ICU Level 1 and Level 2 judging certifications as per requirements defined on the [ICU Web Page](#). It will also be valid to re-certify judges with existing certifications.

Note: there will be a separate event held in Vienna in late February / early March of 2017, which will be open only to certified and experienced judges for the sole purpose of re-certification (one day for Cheerleading, one for Cheerdance).

The ECU will **guarantee** a minimum of one (1) spot for each ECU Member Federation whose application is received by 15th August 2016. After this date, available space will be filled on a first come first served basis.

Participation in the ECU Rules **Round Table** is limited to a maximum of **two (2) participants** per ECU Member, at no additional charge.

Food and drinks will be provided to all participants during the breaks, including lunch.

The final schedules for all days will be communicated no later than 1st September 2016 (after applications).
