Participation in the **ICU Judges Re-certification courses** is only open to judges from ECU members who have previously achieved at least ICU Level 2 Judge certification against a participation fee (see pricing below). ICU is supporting these courses by providing top judging experts. ICU Judges Re-certification courses will run in parallel to the Safety Rules Trainings, however scheduling allows several combinations of trainings and courses to be made.

A preliminary schedule is attached to this document. Actual breaks will be made based on the progress of the workshops. Food and drinks will be provided to all participants during the breaks, including lunch. The final schedule will be communicated no later than 16th February 2016 (after receiving the applications).

Participation in the **ICU Safety Rules Trainings** is open to all interested individuals from ECU members¹ against a participation fee (see pricing below). The trainings will be run by ICU experts on safety rules. The certifications at the end of each training will count toward eligibility for safety judges' positions for ECC 2017 in Prague. Safety judges' trainings will run in parallel to the ICU Judges Re-certification courses, however scheduling allows several combinations of trainings and courses to be made.

A preliminary schedule is attached to this document. Actual breaks will be made based on the progress of the workshops. Food and drinks will be provided to all participants during the breaks, including lunch. The final schedule will be communicated no later than 16th February 2017 (after receiving the applications).

Participation in the **ECU Head & Quality Judges Workshop** is open to all participants registering to attend either the ICU Judges Re-certification courses or ICU Safety Rules Trainings. The workshop is intended primarily for head judges and judges that deal with quality control of the judging process on any level of competition as well as to provide a forum to discuss processes, procedures and good practices related to quality assurance of competition results. The certification at the end of the workshop is intended to count toward eligibility for head and quality judges' positions at ECC 2017 in Prague.

Participation in the **ECU Judging Ethics Workshop** is open to all interested participants registering to attend either the ICU Judges Re-certification courses or ICU Safety Rules Trainings. The topic of judging ethics is relevant to judges in all positions and the goal of the workshop is to spread a unified set of ethical boundaries for judges as well as discuss the various views on those boundaries in different environments.

¹ While all attempts will be made to accommodate all applications, ECU reserves the right to limit the number of participants to the space available at the venue with priority given to ECU Member national rules body representatives and ECU registered judges.

Participation in the **ECU Judges Round Table** is open only to ECU Members, and will be limited to a maximum of **two (2) participants** per ECU Member. It is our suggestion that those two representatives be one from the field of cheerleading and one from the field of performance cheer and that they be members of the national judges body. Participation at the ECU Judges Round Table will be available **free of charge** to eligible participants.

The following listed **attendance fees** are for one (1) person to attend one (1) training (either cheerleading or performance cheer) according to the schedule and include food and drinks provided during that training. Attendance fee for one (1) person to attend both the cheerleading and performance cheer training is double to those listed. Attendance fee for one (1) person to attend both the judges re-certification and the safety rules trainings is double to those listed.

The ECU will **guarantee** a minimum of one (1) spot for each ECU Member whose application is received by 14th February 2016. After this date, available space will be filled on a first come first served basis.
