- a) Removal of Kazakhstan from the ECU East Region In the Article 26.2 point 4.5 Kazakhstan is included in the East Region. As Kazakhstan is defined by ICU, IOC, EOC and OCA to be part of Asia, ECU cannot have the country included in their ECU East Region.

Change of wording: Auditors (Article 33.1) should be elected by this year's General Assembly to check the accounts of the present year and report to the next years General Assembly.

Current wording of the article means that auditors who are elected on the General Assembly must check the
