## A. ARTICLE 1 Name and Address

#### **1.1 Name**

European Cheer Union, ECU, is a non-profit European federation, composed of non-profit national federations that promote and regulate the sport of cheerleading in Europe.

#### 1.2 Address

The General Assembly determines the location of the federation. The General Assembly of 2014 decided to register the federation within the EU, in Denmark.

## 2.1 Objectives

The objectives of ECU are:

1. To promote and develop the sport of Cheer in Europe, and its disciplines as described in article 7.1

### Reason for change

As the sport it is decided to be called Cheer by the ICU, and ECU also in its name refers to Cheer, all references refarding the sport have to use the word "Cheer" and not "Cheerleading". The disciplines can be well described in the membership article 7.1

Therefore all the words "cheerleading" in the same article and in other articles too, have to be changed to "Cheer" (except the proposed descriptions in article 7.1)

## Article 7 Categories of members

As it is today

#### 7.1 Member federation

A. ECU is open to national cheerleading federations in Europe, who are not-for-profit and who administer cheerleading in their own country. For national federations who administer more than one sport in their federation, the following requirements must be fulfilled in order to be a member of ECU: etc...

### As it is proposed to change

A. ECU is open to national cheer federations in Europe, who are not-for-profit and who administer cheer in their own country, <u>regardless of its name</u>, <u>being the national body governing cheer and its disciplines</u>, as of today, a) <u>performance cheer and b) cheerleading</u>. For national federations who administer more than one sport in their federation, the following requirements must be fulfilled in order to be a member of ECU: etc...

### Reason for change

Regarding the Olympic recognition of the sport of Cheer, definitions and explanations of the sport of Cheer have to be finalised, according to the international Olympic approach of definitions of what is sport, discipline, category, .

#### **Definitions**

**Sport:** The primary sport held by a Federation **Discipline**: A subtype of a sport and within a sport

Category: The difference, as a subtype of a discipline and within a discipline, used

sometimes to define mostly difference in age or number of athletes

**Division:** A word which usually is used to distinguish a way to separate things in the SAME category, and is used only in such cases, like f.ex. A-league in senior division / B-league in senior division etc.

## **SPORT**

General sport for a Cheer Federation is the Cheer sport, described in many various ways, including "Cheerleading", "Cheering", "Sport of Cheerleading", "Sport of Cheer" and "Sport of Cheering".

#### **DISCIPLINES**

The sport of Cheer includes (today) two disciplines

- a) Performance Cheer, which mainly is the dancing cheer discipline
- b) Cheerleading, which mainly is the acrobatic cheer discipline

#### SUBDISCIPLINE-EVENTS

In each one of these 2 disciplines, the following subdiscipline-events are included (today)

- In Performance cheer
- a) Cheer pom
- b) Cheer jazz
- c) Cheer hip-hop
- d) Cheer high-kicks

#### In Cheerleading

## Article 28 Replacement

#### As it is today

- 28.1 If an elected Board member resigns before the end of her or his term or cannot fulfil her or his duties as Board member at full capacity, the remaining Board members have the right to appoint another eligible member.
- 28.2. A Board member co-opted as a replacement holds temporary office until the next General Assembly, where an election has to be held for the approval of the new Board member.
- 28.2 The term of appointment for a co-opted Board member ends with her or his predecessor's term.

### As it is proposed to change

28.1 If an elected Board member resigns before the end of her or his term or cannot fulfil her or his duties as Board member at full capacity, the remaining Board members, <u>call as his/her replacement the canditate who received the most votes after the one elected during the immediate previous Board elections, and (s)he is not already elected in another position in the Board.</u>

28.2 The term of appointment for the replaced Board member ends with her or his predecessor's term.

## Reason for change

The persons receiving votes by the National Federations during elections have the right to stand as elected replacements at all time.
