Activities in 2018

The ECU Competition Rules Committee has the mandate to advise the ECU Board on all issues related to the ECU Competition Rulebook, its drafting and interpretation.

In fulfillment of its mandate, the Committee conducted the following main activities in 2018:

- Provided safety judges for the ICU World Championships and proof-read the 2018 ICU • Rulebook to that end;
- Reviewed and proof-read the 2019 Rulebook of the ICU word by word in lights of changes for the new season:
- Proposed and implemented all preparations for the changes of the 2019 ECU Competition • Rulebook in accordance with the Rulebook of the ICU;
- Successfully organized and lectured at the annual Rules Conferences together with top rated • experts from the ICU and IASF with more than 50 participants from over 17 different federations, also including a rules round table for an informal exchange of views (Vienna, September 2018);
- Produced and updated the ICU and ECU rules lecturing materials for Cheerleading;
- Provided expertise to coaches and teams for national implementation of the ECU Rulebook by conducting the following national rules workshops:
