I invite you to attend the 9th ordinary General Assembly (GA) of the European Cheer Union, which will take place in Saint Petersburg, Russia on Thursday, 27 June 2019

Time: 16:00 – 18:00

Each member federation may attend the GA with the number of delegates according to the Tier of their membership¹ (Tier 1 with 1 delegate, Tier 2 with 2 delegates, Tier 3 with 3 delegates). Every member federation is entitled to one vote. Associate members do not have a vote. Delegates may not represent more than one member. Voting by proxy or letter is not allowed. Members attending the GA must be in good standing.
