Information about the ICU Green Course (Safety Rules Workshops):

Due to increased adoption of the ICU and ECU safety rules on the national level as well as for open international and even commercial competitions, the understanding and consistent interpretation of those rules has become one of the most important requirements for national rules bodies, safety judges and of course coaches. ICU is supporting these trainings by providing **top experts**, who are directly involved in the creation and interpretation of these rules to deliver the safety rules workshops.

The **preliminary schedules** of the safety rules workshops are attached below.¹ However, actual breaks will be made based on the progress of the workshops.

Participation:

Participation in the safety rules workshops is only open to **ECU Member Federations**.

Food and drinks will be provided to all participants during the breaks, including lunch.

Participation in the **ECU Rules Round Table** is open only to ECU Member Federations, and will be limited to a maximum of **two (2) participants** per ECU Member. It is our suggestion that those two representatives be one from the field of cheerleading and one from the field of performance cheer and that they be members of the national rules body (who prepares your national competition rules and answers legality and safety questions from your teams). Participation at the ECU Rules Round Table will be available **free of charge** to eligible participants.

Costs:

The following listed **attendance fees** are for one (1) person to attend one (1) training (either cheerleading or performance cheer) according to the schedule. They include food and drinks provided during that training.

Attendance fee for one (1) person to attend both the cheerleading and the performance cheer training is double (260 EUR).

Prices per person per workshop: 130 EUR

Cancellations and changes to the applications are **not possible** and the applicant is committed to paying the attendance fees invoiced by the ECU.

Accommodation will be the **individual responsibility** of the participants, and bookings have to be made directly with the hotel (see above).
